

There is also an accord between the ANC and certain leaders of the erstwhile Afrikaner People's Front.

We plead as a minority people the grace and the support of the American People.




"Petition

Herewith the undersigned, as members of the National Conservative Party, as supporters of the objectives of the petition or as general public with an interest in the objectives of the petition:

- 1. We demand that the South African government acts without delay to mobilise its security apparatus and its security forces to protect its citizens from what has by now become commonly known as "farm murders". The government is duty bound to protect its citizens.
- 2. We demand that the South African government acts without delay to protect all its citizens, including those of minority ethnic groups, from murder, incitement to murder and incitement and acts of genocide. The government is bound by the South African Constitution and also by International Law to do the same.
- 3. Furthermore we urge the South African government to declare any crimes committed against the farming community as "priority crimes" and to establish specialist investigation and prosecution units to deal with these crimes on a highest priority.
- 4. We also warn the South African government that if they ignore or refuse our lawful and fair demands stated above, then we shall take it that they condone or encourage farm murders, genocide and ethnic cleansing of minority groups.
- 5. Furthermore National Conservative Party shall see that as government failing in its legal duty to protect its citizens and upon mandate we will start to institute legal steps based on criminal, civil and international law against the state president, the ministers concerned in the safety and security cluster, the high command of SAPS and the National Defence Force in their official and personal capacities.

"SELF-DETERMINATION AREA FOR THE AFIKANER/BOER NATION IN THE REPUBLIC OF SOUTH AFRICA

Herewith the official release of the suggested map of the area in which the Afrikaner/Boer people and those of European Descent affiliating them to the Afrikaner/Boer people, will enforce our Right to Self Determination, in terms of the Constitution of the Republic of South Africa and International Law. Our intent is to establish Sovereign self-determination for our people through any and all legal, political, economic and social ways and through a peaceful process in which we accommodate all other peoples and nations that may be affected.

The map below is the product of the hard work of the gentleman and ladies of the Areas Committee of the Afrikaner Strategic Commission, the ASK. This body is an umbrella body that is inclusive of all the self-determination, conservative and volkseie organisations and parties in South Africa. National Conservative Party is a member and as political party we are uniquely positioned in this fold of patriots that is working towards Afrikaner/Boer freedom. Our great debt of gratitude to them and especially to Colonel Franz Jooste, the leader of the Fatherland's Alliance/Vaderlandsalliansie, who not only chaired the Areas Committee, but was who was intensively involved in the drafting of the map and the actual investigations and research to back the map up as a viable and sustainable option for us to implement.

We must be clear that the map, as it stands now, is a blue print for our claim of rights. It is possible that the final area will differ in size and scope, including areas not included now and in the same way, excluding areas where no mandate for freedom exist. The next phases of the ASK programmes will impact that. As an example, the Northern Transvaal and West Coast are areas that has seen a strong resurgence in fervour for freedom.

The area demarcated complies with all standards and principles for the establishment of a state. It is the area in South Africa where the vast percentage of the Afrikaner/Boer population already resides and are economical active. In numbers, it is also an area where the Afrikaner/Boer enjoys a numerical majority if the vast concentrations in Pretoria, Areas around Johannesburg, Bloemfontein, the South Coast towns and cities and the suburbs of Cape Town is calculated in. The area is encompassed in one single block with defensible borders. It is economically strong and fiscally sustainable.

The area also includes the areas on which the Afrikaner, and later Boerevolk, the Boer nation, has by far, the strongest historic and territorial claims. The areas mostly encompass areas that were virgin land that we as a nation occupied before any other nations, bought from others, received as gifts from others, established states and republics on and for which we fought hostile conflicts and wars. The map has been drawn specifically as not to include tribal lands of other nations or those lands that could form the basis of legitimate efforts of secession of others. The Western, Southern and parts of the Northern Cape has been Afrikaner lands for centuries. As we do not intent to go into hostilities with our future neighbour states, we will follow peaceful routes in settling any disputes we may have with others though.


The map shows there for a viable and sustainable Boer State that can be rightfully enforced through a territorial claim to secession.


