

## **VIDEO AND INTERVIEW AGREEMENT**

### **CONSIDERATION:**

Michael T. McKibben (hereinafter "Grantor") was interviewed by employees of Flowing Streams, Inc. I hereby irrevocably grant and assign to Flowing Streams and its employees, agents, licensees, and future affiliates (hereinafter, "future affiliates" shall only contemplate those entities wholly owned and controlled by Flowing Streams, Inc.) the right to copy, reproduce, sell, distribute, transmit, broadcast, exhibit, digitize, display, and use all, or a portion of the Content, as well as any documents or photographs that I have given to Flowing Streams, and to quote or paraphrase, in proper context, all or any portion of the Content, including to modify, edit or otherwise use the Content as well as my name, voice, appearance, image, likeness, and performance as well as the results and proceeds thereof, if applicable, in connection with the Work and the exploitation and promotion of the Work in all forms and media including advertising and related promotion that Flowing Streams may deem appropriate, throughout the world. I understand and agree that Flowing Streams owns all rights and proceeds to the Work. I understand that my image may be edited, copied, exhibited, published and/or distributed. I also understand that material may be used individually or in conjunction with other media in any medium, including without limitation, print publications, digital publications, and/or the public broadcast for any lawful purpose. I hereby waive the right to inspect or approve any use of the Content. There is no time limit on the validity of this release nor are there any geographic limitations on where these materials may be distributed.

I hereby acknowledge and grant Flowing Streams and its employees, agents, licensees and future affiliates, all ownership rights and the irrevocable right and permission to copyright, publish, sell, and distribute the Interview and the Work. I understand that Flowing Streams will be the sole owner of all copyright and other rights in and to the Work and may assign such rights as necessary. My consent and release shall not, however, continue to any bona fide purchaser of the Work, In the event Flowing Streams intends to sell the its rights and ownership in the Work to a third party, I retain the right to give consent, in writing, regarding the use of the Content in the

Work owned by a purchasing successor.

Furthermore, it is expressly understood and agreed by the parties hereto that Flowing Streams is allowed to, without limitation, make, use, and/or distribute ancillary products under the Flowing Streams platform, in any way, and for Flowing Stream's partners and friends and for using the Content, or the Work, in whole or in part, in print, audio, video, electronic and/or digital format, worldwide, involving any other party, without prior consent or further compensation to me. Flowing Streams warrants, however, that any use will be within Flowing Stream's traditional means, methods and broadcasting.

**RELEASE:**

I hereby release and discharge Flowing Streams from any and all claims that may arise regarding the use of the Interview, including, without limitation, any claims based on the right of privacy, the right of publicity, copyright, and defamation or any other right. I acknowledge that I have no ownership rights in the Work.

I understand and agree that Flowing Streams is not obligated to utilize the rights granted in this Agreement.

I have read and understood this agreement and I am over the age of 18, of sound and competent mind.

This agreement expresses the complete understanding of the parties.

All rights, licenses and privileges herein granted to Flowing Streams are irrevocable and not subject to rescission, restraint or injunction under any circumstances. Nothing herein shall be construed to obligate Flowing Streams to produce, distribute or use any of the rights granted herein.

This Authorization and Release shall be construed according to the laws of the State of Florida, where jurisdiction shall lie within the County of Indian River. I hereby waive jurisdiction in any other place. This agreement contains the entire understanding of the parties.
